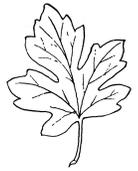

The Speech Advisory Committee has done yeoman's work on revising wording of rules and evaluation sheets to make them clearer, and to facilitate better adjudication. The Board of Control voted to implement these with the 2015-16 school year and will continue piloting them this year, and seeking feedback. State Speech Reminders

Remember if you plan to enter *more than four* groups between Group Interpretation and Play Acting, you **must** book a **Saturday** timeslot for State Speech. Also, remember judging requirements: you must provide one judge for 1-8 entries, two judges for 9-19 entries, and three judges for 20+ entries.
